CONSUMER CREDIT COUNSELING SERVICE OF NORTHWEST INDIANA, INC. is a non-profit community service organization, funded in part by creditor contributions. We offer the following services:

- An administered debt repayment program (participation in counseling does not guarantee enrollment in debt repayment plans to repay credit-grantors and all enrollments are voluntary.)
- Financial education programs on money management, wise use of credit, housing issues, and wise buying decisions. Educational programs are provided to a number of audiences that include the general public, in-house corporate presentations, community agencies, school/educational institutions. Special presentations on specific subjects such as; First Time Homebuyers and HECM counseling are also available by appointment only.

The following contribution schedules generally apply to programs:

COUNSELING

Consultation \$50.00
Counseling sessions are 60 minutes and includes budget, listing of your debts with schedule payments to them, plan option forecast and income/expense summary.

DEBT REPAYMENT PROGRAM:

Start up fee \$30.00 **(required if you join a Debt Management Plan)**
Monthly maintenance fee \$25.00
Active Restart fee \$30.00
Electronic – Service fee \$15.00 per year

EDUCATION:

Credit When Credit Is Due \$50.00 **(required if you join a Debt Management Plan)**
Education department has educational workshops for Credit When Credit Is Due. Spouses or another sharing the living expenses may always attend for no additional contribution. Additional books, within a family, may be purchased at \$25.00.

HECM (Reverse Mortgage)

Certificate \$50.00
May be paid at time of counseling or included in financial closing costs. The client is not obligated to receive, purchase, or utilize any other services offered by the organization, or its exclusive partners, in order to receive counseling services.

PRE-BANKRUPTCY FILING:

Certificate \$50.00
Counseling sessions are 60-90 minute briefings includes personalized budget with certificate. **Fee may be waived with referral letter from legal aid, social service, or upon a counselor's recommendation.**

Specialty workshops Fees vary depending on program.
Schools Fees vary depending on program
